

NOTICE ON PROCESSING AND PROTECTION OF THE PERSONAL DATA FOR COMMERCIAL ELECTRONIC MAIL FORM AND POLIN VISITOR FORM

We, as a data controller, are processing your personal data as given below in accordance with the Personal Data Protection Law No. 6698 and other applicable legislations.

1. Who is Responsible for Security and Processing of Your Personal Data?

We are responsible for the security of all your personal data that you have submitted to us in the capacity of "data controller" under the Personal Data Protection Law No. 6698.

2. For What Purposes Your Personal Data Are Processed?

Your information that you have left during your visit to our websites such as IP, location, and visit history are processed to ensure the security of the website, correct the errors which may arise at the website, and follow the interest to our products and services and thereby, improve our marketing strategies.

The statistical data collected to improve our product and marketing strategies are created by deleting the direct identifiers and thereby, they are anonymous data. The anonymous data are the data that cannot be correlated with identified or identifiable natural person and they do not contain records concerning your identity.

You can share your contact information with us by filling the information registration area on our website or Polin visitor card. Your e-mail address, name, surname, telephone number, country information, and name of the company where you work and/or you are authorized, are asked in the information registration area on our website. There are areas such as activity, date, city, company name, name-surname, title, office address, company profile, telephone number, fax, website, e-mail address, request for proposal (brochure, price, project, appointment), notes, and commercial electronic mail in the Polin visitor card, but all these are optional. The data that you will share here with your consent is processed to inform you about Polin products and services and conduct market research surveys and customer satisfaction studies.

If you generate a demand to receive commercial electronic mail over the information registration area on our website, the log-in information concerning the device where you have created the demand is processed to ensure the process security and to fulfill our liabilities under the provisions of the Law on Arrangement of the Electronic Trade No. 6563 and applicable legislation.

3. To Whom and For What Purposes Your Personal Data Can Be Transferred?

Persons and auxiliary service providers required for the performance of the service

Your personal data can be shared with our technical solution partners with whom we work to render this service to provide the services you request (commercial electronic mail sending and other services that you will demand through Polin visitor form) flawlessly, fast, and safely.

Persons required to be shared by law

Your personal data can be transferred if it explicitly is foreseen in the laws, there is a judicial or administrative order given in compliance with the laws and/or it is required for the fulfilment of our legal liabilities but limited to concerned person or institution only.

Law service providers

To protect either your rights or the rights of our Company or to fulfill our legal liabilities, your personal data can be transferred to law offices and consultancy firms from which we get support in the fields of law, tax, and similar areas if it is mandatory for these purposes only and other related parties and authorized bodies and organizations with whom transfer is required for the purposes determined.

Agencies and advertisers

Some of the personal data can only be shared with advertisers in an anonymized form collectively together with the information of other users to ensure that the ads can be customized to the target audience. The anonymized data are information that cannot be linked to the concerned person and they do not contain your identification information or make your identity identifiable. Your privacy is guaranteed in anonymized data.

Polin Group companies

Your personal data can be transferred to the relevant Polin Group Companies to make job-sharing between Polin Group Companies¹ and the Company and to ensure business management.

By What Methods and Based on Which Legal Reasons are Your Personal Data Collected?

Your personal data are collected through the form you can fill in the information registration area on our website or through the Polin visitor form.

The legal reasons for the collection of your personal data depending on the nature of the data are as follows; your personal data are processed with explicit consent when it is explicitly foreseen by the laws, the data processing is mandatory for execution of the agreement, it is required to fulfill our legal liabilities and it is required for legitimate interests of the data controller.

4. What Are the Rights That You Have on Your Personal Data?

Under the Personal Data Protection Law No. 6698, everyone can exercise the following rights by applying to the data controller:

- a) to learn whether personal data relating to them are processed,
- b) to request information if personal data relating to them are processed,
- c) to learn for what purposes personal data relating to them are processed and whether these data are used in line with these purposes,,
- d) to have knowledge of the third persons to whom personal data relating to them are transferred in the country and overseas,,
- e) to request rectification of personal data relating to them in cases where they are processed incompletely or inaccurately,
- f) To request the deletion or destruction if the reasons for processing the personal data are no longer available,

- g) to request notification of the third persons to whom personal data relating to them are transferred, with respect to the operations conducted in accordance with the subparagraphs (e) and (f),
- h) to object to any result ensuing to their detriment through analysis of personal data processed especially by means of automatic systems,
- i) to request compensation for damages caused by unlawful processing of personal data.

You shall clearly state the right/request that you want to exercise in your request and make explanations by adding all information and document subject to your request. The requests that are notified to us and fulfill -necessary requirements will be concluded in 30 (thirty) days depending on the quality of the request and the result will be notified to you in writing or electronically in compliance with the mode of feedback that you have preferred.
